Pursuant to Idaho Code §30-1-61, and the authority of resolution of shareholders and directors of the corporation dated the 20% day of December, 1985, the undersigned officers of the corporation render these Articles of Amendment and represent as follows:

- (a) Name of the Corporation: Paul Jensen and Associates, Architects, P.A.
- (b) Amendment adopted: That Article I of the Articles of Incorporation of Paul Jensen and Associates, Architects, P.A., be amended to read:

NAME: The name of the corporation is Jensen, Ratzlaff & Unrau, Architects, P.A.

- (c) Date of adoption of amendment by shareholders December 1985.
- (d) Share outstanding 251 shares are outstanding and entitled to vote on the amendment, individually and not as a class.
