I, THE UNDERSIGNED, in order the form a corporation for the purposes hereinafter stated, under and pursuant to the provisions of the General Corporation Law of the State of Delaware, do hereby certify as follows:

FIRST: The name of the corporation is LOCAL DIGITAL DISTRIBUTION COMPANY, INC.

SECOND: Its registered office is to be located at 305 South State Street, in the City of Dover, in the County of Kent, in the State of Delaware. The name of its registered agent at that address is the United States Corporation Company.

THIRD: The purpose of the corporation is to engage in any lawful act or activity for which corporations may be organized under the General Corporation Law of Delaware and to develop and demonstrate the technical, practical and commercial viability of a local digital distribution system and to establish a program for production of the necessary hardware for use in this system.


