## ARTICLES OF INCORPORATION.

And we certify, that the objects for which this corporation is formed are: To establish and maintain a church in the Village or town of Blackfoot, County of Bingham, State of Idaho, and in connection therewith, a Parsonage and suitable and customary organizations, for the purpose of public worship and religious training, according to the established rules and dicipline of the Baptist Church of the United States.

That the principal place of business of this corporation shall be the town of Blackfoot, County of Bingham, State of Idaho:

That the term of incorporation shall be fifty years.
