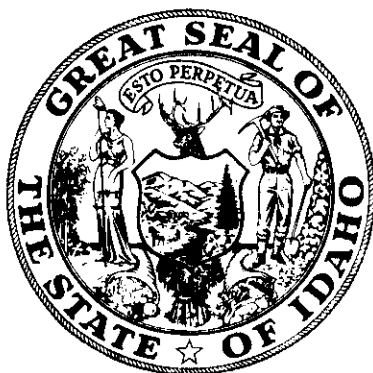

ARTICLES OF INCORPORATION
OF
STEVE'S ELECTRIC, INC.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, all fullage citizens of the United States, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the Laws of the State of Idaho, and to that end do hereby adopt Articles of Incorporation as follows:

ARTICLE I

The name of the proposed corporation shall be:
STEVE'S ELECTRIC, INC.

ARTICLE II

The purposes of the corporation shall be:

(a) To carry on or conduct an electrical installation and contracting business; to solicit, bid, enter into, and perform contracts for the doing of electrical work and the furnishing of electrical machinery, equipment, appliances, accessories, materials and supplies of all kinds; and to do all things necessary, proper, or incidental to the attainment of the foregoing purposes.

(b) To sell, assign, and transfer, convey, lease, or otherwise encumber the lands, buildings, and real and personal property of the corporation wherever situated, and any and all legal and equitable interests therein.

(c) To purchase, hold, sell and transfer shares of its own capital stock, bonds, and other obligations of this corporation from time to time of such extent and in such manner and upon such terms as its board of directors may determine.

(d) Subject to the limitations and restrictions imposed by law: To do all and everything necessary, suitable, or proper for the accomplishment of any of the purposes, the

attainment of any of the objects, or the futherance of any of the powers hereinbefore set forth, either alone or in connection with other corporations, firms, or individuals, and either as principals or agents, and to do every other act or acts, thing or things, incidental or appurtenant to or growing out of, or connected with the aforesaid objects, purposes, or powers, or any of them.

(e) Subject to the limitations and restrictions imposed by law: To carry on business at any place or places within the jurisdiction of the United States, and in any and all foreign countries, and to purchase, hold, mortgage, convey, lease, or otherwise dispose of and deal with real and personal property, at any such place or places.

ARTICLE III

The duration of the corporation shall be perpetual.

ARTICLE IV

The location and post office address of the registered office of the corporation in the State of Idaho is Post Office Box 278, McCall, Idaho 83638.

ARTICLE V

The total number of shares of stock in this corporation shall be 3 shares. All such shares are without par value.

ARTICLE VI

The only class of stock shall be common stock.

ARTICLE VII




ARTICLE IX
