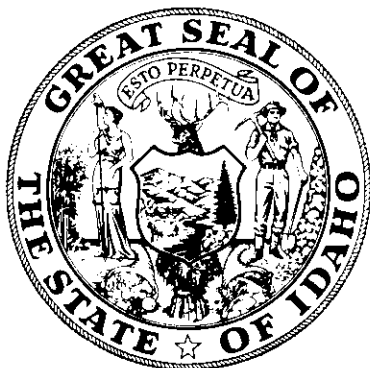

ARTICLES OF INCORPORATION

I.

The name of this corporation shall be NATIONAL FOOD SERVICES, INC.

II.

The duration of the corporation shall be perpetual.

III.

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the laws of the State of Idaho.

The corporation shall be authorized to issue 1,000 shares of common stock, all being of one class, each having a par value of \$1.00, and no preemptive right is to be denied to shareholders.
