2 Articles of Incorporation.

4 We, the undersigned, do hereby associate
5 ourselves together for the purpose of
6 forming a private corporation under
7 the laws of the State of Idaho, and do
8 set forth and declare as follows to wit:

10 I. The name of said Corporation shall
11 be and is, "Payette Valley Bank."

13 II. The purpose for which said Corporation
14 is formed, is to transact a general
15 banking business in the State of Idaho.

17 III. The place where the principal business
18 of said Corporation is to be transacted,
19 is the town of Payette, in the County of
20 Ada, State of Idaho.

22 IV. The term for which said Corporation
23 is to exist, is fifty years.

25 V. The number of the Directors of said
26 Corporation is five (5).
