KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, under and by virtue of the provisions of the Statute of the State of Idaho, providing for the formation of corporations, for certain purposes do hereby certify, agree and declare each for himself and not for another, that we will and by these presents do form ourselves into a body politic and incorporate, under the following provisions and restrictions, to-wit:--

Article I.

The name of said corporation shall be, Marsh Center Irrigating Company.

Article II.

The object for which this company is formed is to build reservoirs, to develope the water supplies also to store up the water in winter to irrigate with when needed.

Article III.

The principal place for a reservoir now under construction is located on Hawkins Greek, Bannock County, State of Idaho, and more fully described in this article as in Tp.10 S., and F.35 East and will be approximately Sec.26, being unsurveyed.

The dam being now about twenty feet high and sixty feet wide on the bottom and fifteen feet wide on top and three hundred feet long costing about two thousand two hundred dollars.

And be it further known that we claim as the site for the

And be it further known that we claim as the site for the said reservoir from the dam which is located as specified in this article and running up the creek in a northerly direction to a point about one mile from the dam, also about one-half mile wide; and be it further known that we have been using the above location to the benefit of this Company for four years, which site has been designated by stakes placed prominently; and be it further known that we claim all streams and tributaries and all water running into Hawkins Greek as appendages to the interest of this Company, also we deny any other Company a right under andy other head or name or control only as The Marsh Center Irrigating Company; and the claims are further confirmed by our bylaws of an earlier date, which have been approved by the Company.

Article IV.

This Company shall continue its corporate existance for the period of ninety-nine years from and after the filing of these presents in the office of Sec.of State.of Idaho.

Article V.

The No. of its directors, or trustees, shall be three, and the following named persons shall constitute the coard of Trustees and manage the business of the Company: -- W.C. Hawkins, F.L. Parris, M.A. Gunter, all of whom reside in Marsh Center, County of Bannock, State of Idaho.

Article VI.

The amount of capital stock shall be Fifty thousand dollars subject to be increased or diminished according to law, and said

capital stock shall be divide into one thousand shares subject to be enlarged or diminished according to the judgment of the Company. Each of the parties to these presents do now own in the Company reservoir shares in No.ranging from two to six.

Article VII.

The Board of Trustees of this Company shall meet immediately after the filing of these presents and adopt by-laws for the government of the Company and all necessary and proper arrangemets for carrying out the object herein expressed and as to them may seem for the best interest of the Company.


