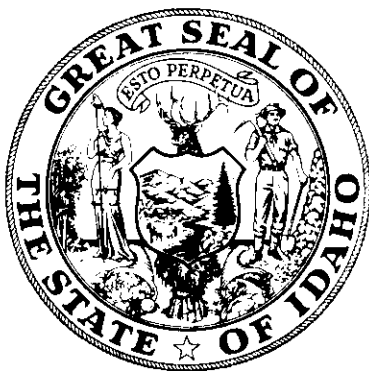

ARTICLES OF INCORPORATION
OF
WESTERN HUMOR ILLUSTRATED, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, hereby adopts the following Articles of Incorporation for such corporation.

ARTICLE I

The name of the corporation shall be WESTERN HUMOR ILLUSTRATED, INC.

ARTICLE II.

The period of existence and duration of the life of this corporation shall be perpetual.

ARTICLE III.

This corporation is organized for the purpose of the transaction of any and all lawful business for which corporation may be incorporated under the Idaho Business Corporation Act.

ARTICLE IV.

The total authorized number of shares of the corporation shall consist of One Hundred (100) shares of Common Stock having a par value of One Hundred (\$100.00) Dollars per share for a total value in stock of Ten Thousand (\$10,000.00) Dollars, all of one (1) class denoted Common Stock, each share being entitled to one (1) vote.

ARTICLE V.

There are no provisions denying preemptive rights.

ARTICLE VI.

Provisions for the regulation of the internal affairs of the corporation are to be set forth in the Bylaws of the corporation

ARTICLE VII.

The address of the initial registered office of the corporation is Route 1, Box 120, Samuels, Idaho 83862, and the name of the initial registered agent at such address is ROY "BOOTS" REYNOLDS.

ARTICLE VIII.


