The undersigned, in order to form a nonprofit corporation under the provisions of Title, 30, Chapter 3, Idaho Code, submits the following Articles of Incorporation to the Secretary of State.

**Article 1: The name of the corporation shall be: Celtic Arts Idaho, Inc.**

**Article 2: The purpose for which the corporation is organized is:**

- A. To publicize, promote, improve, and enhance the understanding and practice of Celtic arts including, but not limited to, dance, music, drama, literature, poetry, language, drawing, painting, and crafts.**
- B. To provide instruction in Celtic arts, and facilities for the conduct and practice thereof.**
- C. To engage in and transact any other lawful activity, solely in furtherance of the foregoing purposes, for which nonprofit corporations may be incorporated under the Idaho State Nonprofit Corporation Act and any successor or amendment to said Act.**
- D. To do such other things as are incidental to the purposes of the corporation or necessary or desirable to accomplish them.**


