

EMMETT, IDAHO**

was filed in the office of the Secretary of State on the 27th day of October A. D. One Thousand Nine Hundred seventy-five and is ~~also~~ recorded on ~~Film~~ ~~Microfilm~~ Record of Domestic Corporations of the State of Idaho, and that the said articles contain the statement of facts required by Sections 30-103, 30-1101 and 30-1102, Idaho Code.

AND I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name stated in the articles, and for *Perpetual Existence* from the date hereof, with its registered office in this State located at *Emmett, Idaho* in the County of *Gem* and as such are subject to the rights, privileges and limitations granted to Religious, Ex-Service Men, Benevolent, Charitable and Fraternal Corporations, as provided in Chapter 11, Title 30, Idaho Code.

ARTICLES OF INCORPORATION

OF

FIRST SOUTHERN BAPTIST CHURCH, INC., OF EMMETT, IDAHO

---

KNOW ALL MEN BY THESE PRESENTS: That Edward Snow of 1104 South Hayes Avenue, Emmett, Idaho, John Strauchon of Route 2, Box 236 A, Emmett, Idaho, and Sharrell Stickler of Route 1, Box 109, Emmett, Idaho, citizens of the United States, natural persons of full age, and duly elected and qualified trustees of First Southern Baptist Church of Emmett, Idaho, together with other voting members of this church, associate ourselves together for the purpose of forming a religious corporation under the laws of the State of Idaho, and for this purpose we do hereby certify and declare:

1. CORPORATE NAME. The name of this corporation is and shall be FIRST SOUTHERN BAPTIST CHURCH, INC., OF EMMETT, IDAHO.

2. LOCATION AND POST OFFICE ADDRESS. The location and post office address of the office of this corporation in the State of Idaho shall be at Emmett, Idaho.

3. PURPOSES AND OBJECTS. The purpose of this church shall be to maintain the public worship of God; to practice the precepts and examples of the church of our Lord Jesus Christ as set forth in the New Testament; to sustain ordinances and doctrines; and to preach and to propagate among all people the gospel of God's salvation by personal faith in Jesus as Saviour and Lord.

This corporation shall be empowered to purchase, acquire, own, hold, and use all such property, both real and personal, as may be necessary for the purpose of carrying into effect the objects and purposes hereinbefore mentioned. To borrow money and to secure the payment thereof by notes and by the mortgaging of any and all property of said corporation. To do all other things necessary to be done in carrying out the purposes and objects of said church.

4. DURATION. The term for which this Corporation is to exist shall be perpetual.

5. MANAGEMENT. This corporation is and shall be managed by a Board of Trustees which at no time shall consist of less than three nor more than thirty-five members, all of whom shall be citizens of the United States and voting members of said corporation who have reached their twenty-first (21) birthday; voting members shall be persons who have joined this church and profess the faith, teachings and support the program of the church by attendance and finances.

6. INCORPORATION. This corporation is a membership corporation without capital stock and is not organized for pecuniary profit or gain.

7. MEMBERSHIP. The trustees shall constitute a Board of Trustees which shall hold in trust and administer all the property of said corporation, real and personal, and shall conduct all its legal and financial business in accordance with such constitution, by-laws and resolutions as such corporation may adopt; and shall be responsible for the promotion, operation and management of said corporation in accordance with said constitution, by-laws and resolutions of said corporation.

The first annual meeting of this corporation shall be held on the second Wednesday of October, 1976 and subsequent annual meetings shall be held at such time as shall be fixed by the by-laws of the corporation. The time and place of such annual meeting, together with its purpose, including the election of trustees, shall be made known to all voting members of this corporation by the minister of the church at least one week prior to the date of such meeting. In case of a vacancy on the Board

of Trustees, the corporation shall at the next regular meeting after such vacancy has occurred, or at a special meeting, upon proper notice to all voting members of said corporation by giving at least one week's notice prior thereto, fill such vacancy by election.

8. MEETING AND TRUSTEES. The title of the persons making these Articles of Incorporation is and shall be Trustees of First Southern Baptist Church, Inc., of Emmett, Idaho; that at a meeting of said First Southern Baptist Church of Emmett, Idaho, held at 223 East Second Street, Emmett, Idaho, on the 8th day of October, 1975, called by the pastor and presiding officer, notice of the time and place and purpose of which meeting was duly given by publication in the Messenger-Index, a newspaper published at Emmett, Idaho, for two weeks prior to the holding of said meeting and by posting a like notice in a conspicuous place on the building where such election was held for the same length of time, the following persons, whose post office addresses are set opposite their respective names, to-wit:
