This matter comes on before me, in chambers, on July 29, 1998, on Plaintiff's Motion for a Temporary Restraining Order. The Court having reviewed the verified Complaint, Plaintiff's Motion for a Temporary Restraining Order, and the Affidavit of Ranell Nystrom in Support of Plaintiff's Motion for a Temporary Restraining Order, and good cause appearing, makes the following findings:

- 1. Unless restrained, Defendants have the power to inflict irreparable injury on Plaintiffs by:
 - a) Conducting business in the name of the North End Neighborhood

Association, Inc.:

- b) Issuing or promulgating any purported notices of meetings which purport to bind the plaintiffs or any other persons to the results of that meeting;
- c) Spending or obligating the funds of the North End Neighborhood Association, Inc., or writing any check, draft or withdrawal order against any bank account belonging to the North End Neighborhood Association, Inc.

These injuries appear at this time to be irreparable, and this Temporary

Restraining Order is granted without notice to freeze the funds of the North End

Neighborhood Association, Inc.;

THEREFORE, IT IS ORDERED AND THIS DOES ORDER:

That the Defendants, Tom Monagle, Jack Storey and Tony Windham, are restrained from the following acts:

- Conducting any business in the name of the North End Neighborhood

 Association, Inc.;
- 2. Issuing or promulgating any purported notices of meetings which purport to bind the plaintiffs or any other persons to the results of that meeting;
- 3. Spending or obligating the funds of the North End Neighborhood Association, Inc., or writing any check, draft or withdrawal order against any bank account belonging to the North End Neighborhood Association, Inc.

This Temporary Restraining Order shall expire 14 days from its issuance, unless the Court, for good cause shown, shall extend the period of its effectiveness, or unless the Defendants shall consent that it may be so extended.

TEMPORARY RESTRAINING ORDER - P. 2

No security shall be required of the Plaintiffs.

Security in the amount of \$\frac{2006}{0000}\$ shall be required of the Plaintiffs for the payment of such costs and damages including reasonable attorney's fees to be fixed by the court as may be incurred or suffered by any party who is found to have been wrongfully enjoined or restrained.
