ARTICLES OF INCORPORATION

OF

KNOW ALL MEN BY THESE PRESENTS that we, JOHN K. DAVIS, STEVEN R. GALLAFENT, DOROTHY G. SCOTT and E. L. SCOTT, citizens of the United States of America, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and to that end we do hereby certify:

Ι

The name of this corporation shall be: METRO TAN, INC.

II

The period of existence of this corporation shall be perpetual.

III

The purpose for which the corporation is formed is to conduct a general business of providing a place and use of machines equipped with sun lamps to the general public from which the skin of those persons using the machines would become tanned. Also for the sale of "sun-tan" machines and sundry items in connection with the business.

The total authorized capital stock of this corporation shall be \$100,000.00, divided into 10,000 shares of the par value of \$10.00 each.
