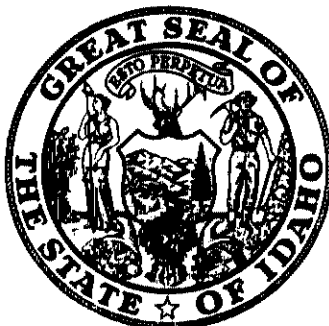
### CERTIFICATE OF INCORPORATION OF

We, the undersigned, do hereby associate ourselves in order to form a corporation for the purpose hereinafter stated and do hereby certify as follows:

1. The name of this corporation shall be INTERNATIONAL SNOWBIRD TRAVEL CLUB, INCORPORATED.

2. The organization is not formed for profit-making purposes. As such the organization shall at all times during the span of its existence maintain an attitude strictly non-sectarian, non-partisan, non-sectional and non-racial, nor shall it, as an organization, take any part in political issues or the affairs of state.

3. The duration of the corporation shall be perpetual, or until dissolved by a majority vote of the Board of Directors.

4. The purpose of the organization is to further fellowship between SnowBird recreational vehicle owners, including the principles of thoughtful camping, ecological awareness, safety in recreational camping, protection of environment, and aid to fellow campers.

5. The INTERNATIONAL SNOWBIRD TRAVEL CLUB will be governed by a Board of Directors consisting of four memberships from any State or Province. A slate of candidates will be presented to the affiliated Chapters by November 1 each year. Each Chapter will respond with one vote per Chapter by December 15. The Board of Directors will take position on the subsequent January 1. Subsequent election procedure will be outlined in the By-Laws.

6. The official mailing address of the INTERNATIONAL SNOWBIRD TRAVEL CLUB is Post Office Box 2792, Hayden, Idaho 83835. The agent designated is the Secretary, Carol Spenst. (3601 HAYDEN PINES WAY, #114, HAYDEN, IDAHO 83835.)

7. The initial Board of Directors (consisting of four members) is as follows:

8. The INTERNATIONAL SNOWBIRD TRAVEL CLUB will consist of an unlimited number of Chapters (defined as a duly chartered local Chapter of the Club). Chapters will be limited to 25 memberships. A membership is defined as the husband, wife, and any dependent children owning one SnowBird recreational vehicle.

9. Chapters may be formed in any State or Province, and shall be assigned a Chapter number by the INTERNATIONAL SNOWBIRD TRAVEL CLUB. Subsequently, the Chapter will assign a number from 1 to 25 to each membership, with the resulting combination being unique to that SnowBird owner (for example, 1-11, or 6-23).

10. Each affiliated Chapter will develop its own charter, by-laws, and dues collection procedure.

11. The INTERNATIONAL SNOWBIRD TRAVEL CLUB may assess dues to each affiliated Chapter and/or Membership as necessary to cover administrative costs of the Board of Directors.

12. Affiliated Chapters will support the INTERNATIONAL SNOWBIRD TRAVEL CLUB by ordering all official and/or logo materials from the international headquarters.

13. The organization shall be governed in all its meetings by parliamentary law as contained in Roberts' Rules of Order."


