The undersigned, acting as incorporator of a corporation under the Corporation Act and other applicable laws of the State of Idaho, adopt the following Articles of Incorporation for such corporation:

**FIRST:** The name of the corporation is: LawForms, Incorporated.

**SECOND:** The period of its duration is perpetual.

**THIRD:** The purpose or purposes for which the corporation is organized are: The transaction and operation of a business and the performance of any and all activities or other lawful business allowed to be performed by a corporation under the laws of the State of Idaho.

**FOURTH:** The aggregate number of common shares which the corporation shall have authority to issue is 100,000 of which 2,000 shall have voting rights and 98,000 shall not have voting rights. The shares shall have no par value.



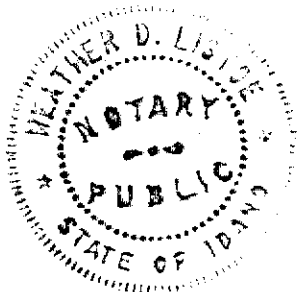
