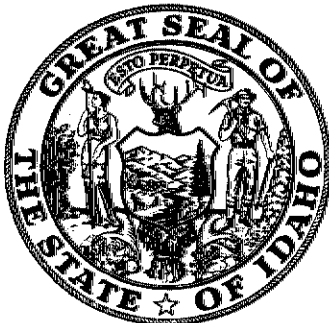

ARTICLES OF INCORPORATION
of

a Non-Profit Corporation

The undersigned, acting as incorporator, in order to form a corporation under the Idaho Nonprofit Corporation Company Act, Title 30, Chapter 3 of the State of Idaho, adopt the following Articles of Incorporation:

ARTICLE 1

The name of this corporation is: EarthWind Inc.

ARTICLE 2

ARTICLE 3

The purposes for which this corporation is organized are: to teach and provide educational material and processes through varied media as well as provide charitable assistance to the public. This educational material will include, but not be limited to, material relating to the development of an individual's integrity and unconditional love and furthering that understanding in relationship and within community.

This corporation is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE 6

The period of the duration of this corporation is perpetual.

ARTICLE 7

This corporation shall be formed as a nonmembership corporation.

ARTICLE 8

Upon the dissolution of this corporation its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or shall be distributed to the federal state or local government for a public purpose.

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Section 501(h) of the Internal Revenue Code), and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to, its directors, officers, or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these Articles.

Notwithstanding any other provision of these Articles, this corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation, contributions to which are deductible under Section 170(2) of the Internal Revenue Code.
