Dear Mr. Baldwin:

The Idaho Department of Finance (Department) is in receipt of your letter dated August 30. 2016, that gave notice of the intent to open two mortgage loan production offices (LPOs) in Idaho. Your letter indicates one LPO will be located at 101 East Main Street, Suite 209, Rexburg, Idaho, 83440 and one at a street address to be determined in Idaho Falls, Idaho. According to your letter, the two LPOs will generate residential mortgage loans only.

Idaho Code § 26-302 governs LPOs operating in the State of Idaho. It describes the activities that may be conducted at a LPO and defines what information is needed in the initial establishment notice, and upon relocation or closure. After reviewing your letter, we determined the information provided sufficiently satisfies the requirements of Idaho Code § 26-302. The Department has no objection to the establishment of LPOs at 101 East Main Street Suite 209. Rexburg, Idaho, and the second location in Idaho Falls, Idaho for activities specifically listed under Idaho Code § 26-302. Please notify the Department of the specific street address of the Idaho Falls LPO as soon as it is determined.
