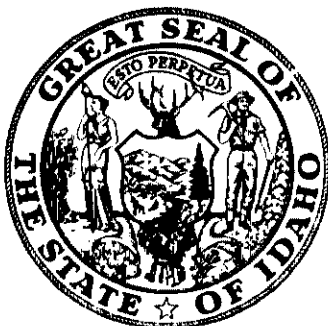

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION
OF HARRIS, INC., GOVERNMENT SERVICES CONTRACTOR

Harris, Inc., Government Services Contractor adopts the following Articles of Amendment to the Articles of Incorporation of Harris, Inc., Government Services Contractor, an Idaho corporation, which Articles are dated August 24, 1981 and filed with the office of the Secretary of State of the State of Idaho on September 8, 1981 (the "Initial Articles of Incorporation"):

One: Articles "First" of the Initial Articles of Incorporation is amended, and restated as amended, to read as follows:

"First: The name of the corporation is W. Harris, Government Services Contractor, Inc."

Two: Except as herein amended, the Initial Articles of Incorporation remain in full force and effect.

Three: We, the President and Secretary of Harris, Inc., Government Services Contractor, hereby certify that, in accordance with Idaho law, the foregoing amendment was unanimously approved by the Board of Directors and by the Stockholder acting at a Special Meeting of the Stockholders of said corporation.




