

Certificate of Incorporation

This is to certify that at a meeting of the Members of the Second Quarterly Conference of Boise Valley Circuit in Idaho Annual Conference of the Methodist Episcopal Church, Citizens of the United States and of the State of Idaho, duly convened according to the Discipline and Usage of the Methodist Episcopal Church at the Central Park M. E. Church in Canyon Co and State of Idaho, on the twenty sixth day of January A.D. 1895, a majority of the Members of said Quarterly Conference being present and desiring to constitute a religious Society under the name & style of the Methodist Episcopal Church at Middleton in the County of Canyon, State of Idaho; and cause the same to become incorporated according to law, the undersigned Citizens of Canyon County were duly elected, as provided in the Discipline of the Methodist Episcopal Church, Trustees of said Society or Church to serve for the term of one year and until their successors are ^{duly} elected, as provided in the Discipline of the Said Methodist Episcopal Church.

It was further ordered and agreed that the undersigned should file in the office of the Secretary of State of the State of Idaho a Certificate of Incorporation as required by law in order that said Society, their Associates and Successors might become a body Corporate, and as such continue Fifty years and be entitled to all the rights, privileges and immunities provided by law. That the principal place of business ^{of this incorporation} shall be the Methodist Episcopal Church at Middleton, Idaho. Also that said trustees and their Successors shall have the custody of all the

property, real and personal belonging to said Corporation situated in Canyon County, State of Idaho, in accordance with the Discipline and Usages of the Methodist Episcopal Church, as from time to time declared by the General Conference of said Church in the United States of America.
