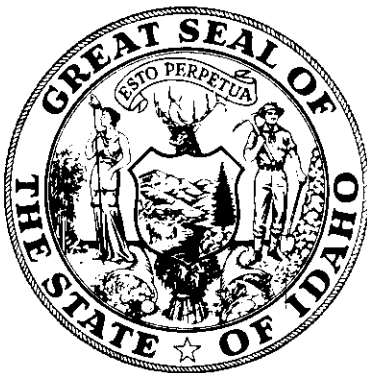

AMENDMENTS TO ARTICLES OF INCORPORATION

OF

HUMAN LINKAGES, INC.

At a meeting held on May 13, 1985, a majority of the members voted to adopt these amendments to the Articles of Incorporation.

ARTICLE III

NON-PROFIT STATUS

Amended to include in the first paragraph: "and the corporation is organized exclusively for religious, charitable, scientific, literary, or educational purposes within the meaning of section 501(c)(3) of the Internal Revenue Code."

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code.

ARTICLE IX

TERMINATION OF CORPORATION

Amended by the addition of a second paragraph: "Upon the winding up and dissolution of the corporation, after paying or adequately providing for the debts and obligations of the corporation, the remaining assets shall be distributed to a non-profit fund, foundation or corporation which has established its exempt status under section 501(c)(3) of the Internal Revenue Code."
