ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF NORTH IDAHO CHILDREN'S HOME, INC.

OS MAY O THE

Pursuant to the provisions of § 30-327, Idaho Code, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The present name of the corporation is North Idaho Children's Home, Inc.

SECOND: The following amendment of the Articles of Incorporation, as the same have been previously amended, was adopted by the members and directors of the corporation by unanimous written consent:

That Article I be amended to change the name of the corporation from North Idaho Children's Home, Inc., to Northwest Children's Home, Inc., and, to that end, that Article I as now written be deleted and that the following language be substituted therefor:

"ARTICLE I. The name of this corporation shall be 'Northwest Children's Home, Inc.'"

That Article VI of the Articles of Incorporation be amended to permit the classification of directors and, to that end, that Article VI as now written, be deleted and that there by substituted in lieu thereof the following:

"ARTICLE VI. The directors of the corporation shall be such number of persons not less than five (5) and not more than thirty-five (35) as may be prescribed by the Bylaws. The directors shall be divided into two classes. Each class shall be as nearly equal in number as possible. After the classification of directors has been instituted, directors shall serve for a term of two (2) years, with the members of one class being elected in odd numbered years and directors in

the other class being elected in even numbered years."

THIRD: The amendment set forth above was adopted by a consent, in writing, signed by all members entitled to vote with respect thereto.
