ARTICLES OF INCORPORATION
OF

The undersigned, acting as Incorporator of a General Business Corporation under the Idaho Business Corporation Act. (Section 30-1-1 et.seq.) does hereby adopt the following Articles of Incorporation.

I

The name of this Corporation is PANHANDLE PRODUCTIONS, INC.

II

The period of duration of this Corporation shall be perpetual.

III

The purpose or purposes for which the Corporation is organized are the transaction of any and all lawful business for which Corporations may be incorporated under the Idaho Business Corporations Act.
