ARTICLES OF INCORPORATION of

THE PIDCOCK COMPANY, INC.

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, all of whom are citizens of the United States of America, residents of the State of Idaho, and of legal age, have today voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and we hereby certify:

I.

The name of said corporation shall be "THE PIDCOCK COMPANY, INC."

II.

The duration of the corporation shall be perpetual.

III.

The location and post office of the registered office of the corporation in the State of Idaho shall be the Village of Inkom, State of Idaho.

IV.

The authorized capital stock of the corporation shall consist of Fifty (50) shares of no par value common stock. All of the stock shall be of the same class, have the same powers and voting rights and shall not be assessable for any purpose whatsoever.

۷.

The business of this corporation shall be managed by a Board of Directors consisting of no less than three directors. The qualifications,

the term of office, manner of electing directors, the number of directors to be elected, the time, place and manner of calling meetings, and the powers and duties of the directors shall be prescribed by the By-Laws. The names and post office addresses of the directors until the first annual meeting of the stockholders are as follows:

VI.

The purposes for which said corporation is organized are as follows:

- A. To cultivate and improve farms, gardens and agricultural lands, to raise and improve livestock, and incidentally to own and control in fee simple, lease or otherwise, such lands, buildings and personal property necessary to the conduct and operation of such business.
- B. To buy, sell, store and otherwise handle and deal in grain, hay, seeds and produce of all kinds, and generally to do a grain storage and commission business in the State of Idaho, and elsewhere, and to buy, sell, mortgage, lease and deal in real estate and personal property, including grain elevators, warehouses, and other property, in and about the transaction of its business, and to do and perform any and all acts and things as may be necessary in and about the carrying on of the business aforesaid.
- C. To purchase, own, and sell all types of business equipment, business machines and personal property and to hypothecate same; to deal in, lease and broker leases of all types of business equipment and personal property.

- D. To buy, own, sell, hypothecate, and to have the power to do each and every thing necessary to deal in real property.
- E. To borrow money for its corporate purposes and to make, accept, endorse, execute and issue promissory notes, bills of exchange, bonds, debentures or other obligations from time to time for the purchase of property for any purpose in or about the business of the corporation, and if deemed proper, to secure the payment of any such obligations by mortgage, pledge, deed of trust or otherwise.
- F. To purchase stock, securities and other evidences of ownership or indebtedness in corporations and other forms of business organizations, and specifically to have the power to purchase its own corporate shares of stock.
- G. To have the powers and to do those acts, things, and deeds set forth in Section 30-114, Idaho Code, and any and all amendments thereto.
- H. To do all acts and things necessary to carry out the purposes and intent expressed in the above provisions, and each and every necessary, suitable or advisable act or thing for the accomplishment thereof.

VII.

The power to repeal and amend the By-Laws and adopt new By-Laws is hereby conferred upon the directors, as well as upon the shareholders, to be exercised by such vote of the directors or of the shareholders as provided in said By-Laws; provided, however, that not less than a majority thereof may be fixed by the By-Laws.
