

ARTICLES OF INCORPORATION

SISTERS OF THE VISITATION, OF LEWISTON, IDAHO.

KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned citizens of the United States of America, and residents of the State of Idaho, over the age of twenty-one years, have this day voluntarily associated ourselves together for the purpose of forming a Corporation under the laws of the State of Idaho.

AND WE DO HEREBY CERTIFY AS FOLLOWS:

First,

That the name of said Corporation is **SISTERS OF THE VISITATION, OF LEWISTON, IDAHO.**

Second,

That the purposes for which it is formed are to govern, conduct, maintain and manage Saint Joseph's Academy, a Catholic institution established at Lewiston, Nez Perce County, State of Idaho, for the education and moral training of girls and young ladies, and to purchase, receive and hold real and personal property necessary, proper and useful for Academy buildings and equipment and the successful government, conduct, maintenance and management of said Academy and the education and moral training of the students thereof; also when necessary and to the best interest of said Academy and this Corporation, to bargain, sell, convey or otherwise dispose of said real or personal property.

Third,

That the place where its principal business is to be transacted, shall be the City of Lewiston, Nez Perce County, Idaho.

Fourth,

That the term for which it is to exist is fifty years from and after the date of its incorporation.

Fifth,

That the number of its Trustees shall be five and the names and residences of those who are appointed for the first year are:


