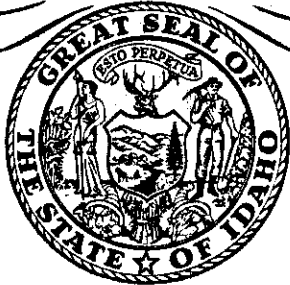

ARTICLES OF INCORPORATION
OF

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, each one a natural person, over the age of 21 years, and a citizen of the United States of America, have this day voluntarily associated ourselves together for the purpose of forming a corporation under and pursuant to the laws of the State of Idaho, and we do hereby certify:

ARTICLE I

The name of this corporation shall be the NORTHWEST DISTRICT BIBLE MISSIONARY CHURCH, INC.

ARTICLE II

The purpose or purposes for which this corporation is formed are as follows:

A. To engage in the dissemination of the principles and doctrines of Christianity and to engage in any or all welfare and/or benevolent practices incidental thereto.

B. To solicit funds and property; to acquire by gift, legacy, devise, purchase or otherwise, property of every kind and nature both real and personal, or mixed, and to lease, mortgage, improve, pledge, sell, convey or otherwise encumber or dispose of such property.

C. To invest and expend funds and to distribute funds to such charitable or benevolent purposes as the corporation may deem fit.

D. To do all acts and things necessary, convenient or expedient to carry on the above mentioned purposes.

ARTICLE III

DURATION

The period of existence and period during which it is to continue as a corporation is perpetual.

ARTICLE IV

ARTICLE V

This corporation is organized on a non-stock basis and all proceeds shall be used directly or indirectly in the disseminating of the doctrines of Christianity.

ARTICLE VI

DIRECTORS

The affairs of this corporation shall be directed by a Board of Directors consisting of no fewer than six (6) nor more than twelve (12) persons, one-half of whom must be ministers and the other half shall be composed of laity, the exact number, within such limitations, to be determined at the annual meeting of the corporation and they shall serve on the Board for a one-year term.
