ARTICLES OF INCORPORATION OF '92 SEP 21 PM 2 38

Pursuant to the provisions of Section 30-1-61, Idaho Code, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

I.

The current name of the corporation is American Heating, Solar & Refrigeration, Inc.

II.

The following Amendment to the Articles of Incorporation was adopted by the Shareholders of the Corporation on June 18, 1992, in the manner prescribed by Section 30-1-59, Idaho Code:

Paragraph I of the Articles of Incorporation is amended to read as follows:

"I.

The name of the corporation is "American Heating & Refrigeration, Inc."

III.

Paragraph VI of the Article of Incorporation is amended to read as follows:

"VI.

The street and mailing addresses of the initial registered office of the corporation are One Quigley Gulch Road, Blaine County, Idaho (83333), and Post Office Box 831, Ketchum, Idaho (83340), respectively, and the name of its initial registered agent at such addresses is John D. Mills."

IV.

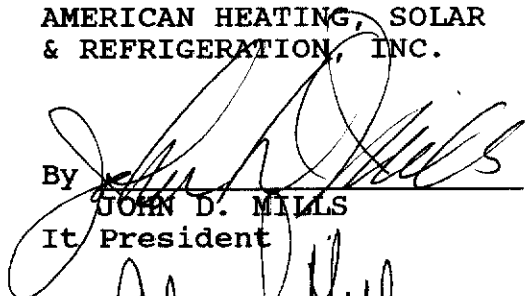

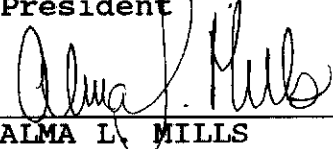
