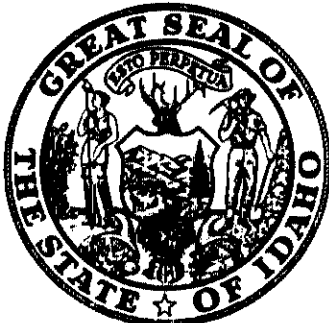

# ARTICLES OF INCORPORATION

## OF BARD'S QUEST, INC.

KNOW ALL MEN BY THESE PRESENTS: That the undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

I

The name of the corporation shall be BARD'S QUEST, INC.

II

The corporation shall exist in perpetuity.

III

The address of the initial registered office of this corporation in the state of Idaho shall be 305 West Fort Street, Boise, Idaho 83702, and the name of the initial registered agent at that address shall be DONALD W. LOJEK.

IV

The purpose for which this corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

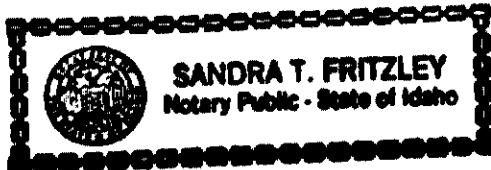
