I, the undersigned, a natural person over the age of eighteen years, do hereby form a professional corporation under the laws of the State of Idaho, as contained in Chapter 13 of Title 30, Idaho Code, entitled "Professional Service Corporation Act," and to that end do hereby certify:

ARTICLE I

NAME

The name of the corporation shall be Richard S. Sabey, Chartered.

ARTICLE II

PURPOSES AND POMERS

The purposes for which the corporation is organized are:

- A. To engage generally in the professional practice of certified public accountant as the same is now or hereafter defined by statute, rule, or regulation;
- B. To invest funds in real property, personal property, mortgages, stocks, bonds, or any other types of investments and to own or lease real or personal property necessary for the rendering of such professional services;
- C. CORPORATE STOCK

The aggregate number of shares which the corporation shall have authority to issue is 10,000, all of which shall have a par value of \$1.00 per share.
