#### CERTIFICATE OF LIMITED PARTNERSHIP

OF

#### BROJO, A LIMITED PARTNERSHIP

WE, THE UNDERSIGNED, being all of the subscribers whose name and addresses are set forth at the foot of this Certificate, for the purpose of forming a limited partnership (the "Partnership") pursuant to the provisions of the Uniform Limited Partnership Law of the State of New Jersey do hereby certify, state and agree:

FIRST: The name of the Partnership is Brojo, a limited partnership.

SECOND: The business and purposes of the Partnership business are, either directly or indirectly through participation as a general partner of another general or limited partnership, (a) to acquire the business and assets, subject to certain of the liabilities, of Bro-Dart Industries, a New Jersey corporation, and its subsidiaries (collectively, "Bro-Dart"); (b) to conduct and carry on the business and manage the assets acquired and such other related business and assets as may subsequently be acquired or developed by the Partnership (collectively, the "Operations"); (c) to employ personnel to manage the Operations; and (d) to take all actions necessary and appropriate in

order to consummate such acquisition and thereafter to carry on the Operations. The Partnership shall conduct no other business.

THIRD: The location of the principal place of business of the partnership is at Plaza 9 Building, 900 Route 9, Woodbridge, New Jersey 07095.

FOURTH: The general partner of the Partnership is Nubro, Inc., a Delaware corporation, with an address at 306 South State Street, Dover, Delaware 19901. The limited partner of the partnership is Goldome Bank for Savings, a mutual savings bank organized under the laws of the State of New York, with an address at One Fountain Plaza, Buffalo, New York 14203.

FIFTH: The term of the Partnership shall commence upon the filing of this Certificate of Limited Partnership and shall continue until December 31, 2023 unless sooner terminated by mutual agreement of the partners or otherwise as set forth in the Limited Partnership Agreement.

SIXTH: The amount of cash contributed by the limited partner to the capital of the Partnership is \$100. No other property of any form has been contributed by the limited partner.

SEVENTH: Subject to and upon the closing of the acquisition of the business and assets of Bro-Dart, the limited partner shall contribute \$249,900 of additional capital to the Partnership.

EIGHTH: The time when the capital contribution of the limited partner is to be returned is upon dissolution of the Partnership.

NINTH: Initially, 90% of all items of net income or net loss for each fiscal year of the Partnership ending on or before December 31, 1987, shall be credited or charged, as the case may be, to the limited partner. Thereafter, 10% of all items of net income or net loss for each fiscal year shall be credited or charged, as the case may be, to the limited partner.

TENTH: The limited partner shall have no right to substitute an assignee as a contributor in his place without the consent of the general partner.

<u>ELEVENTH</u>: The partners shall not have any right to admit additional limited partners.

TWELFTH: The limited partner shall not be entitled to demand and receive property in kind in return for its capital contribution.
