THIS IS TO CERTIFY that I, the undersigned, hereby incorporate pursuant to the Laws of the State of Idaho providing for the formation of corporations for profit, for the purposes and with the powers hereinafter stated.

I

The name of this corporation is:

CURT CLARK ENTERPRISES, INC.

II

The general nature and purpose of this corporation shall be the operation of a retail automotive service station dealership and the performance of any and all activities normally associated therewith; and also

To engage in any business activity permitted under the Laws of the United States and of this State.

The closest Standard Industrial Classification (SIC) Code List Category would be Division G, 5540, "Gas Service Stations".

III

The existence of this corporation is to be perpetual.

IV

The principal offices of this corporation shall be located at:

and branch offices may be located in other places as may be designated from time to time.

V

The amount of capital with which this corporation shall commence business shall be no less than Five Hundred Dollars (\$500.00).

VI

The maximum number of shares of stock that this corporation is authorized to have outstanding at any time is Five Hundred (500) shares of common stock, each share having a par value of One Dollar (\$1.00).

VII

Each holder of common stock of this corporation shall be entitled to One (1) vote for each share of common stock held.

Initially, this corporation shall have One (1) director. The number of directors may be increased from time to time.


