KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, all being citizens of the United States and being of legal age, have this day voluntarily associated ourselves for the purpose of forming a non-profit cooperative association pursuant to the provisions of Title 29, Chapter 10, of the Idaho Code Annotated, and for that purpose we do hereby certify as follows:

ARTICLE I

That the name of this corporation shall be: "Pocatello Rental Housing Association, Inc."

ARTICLE II

This corporation is formed for the purpose and shall have the power:

- (1) To advance the general welfare and projects of persons, firms, associations and corporations who own, in entirety or in part, and/or who operate residential rental properties;
- (2) To own, lease, exchange, or otherwise acquire and dispose of, personal and real property necessary, incidental, auxiliary or convenient to the business of this corporation and its purposes and object;
- (3) To exercise and perform all rights, power, privileges and duties granted to or imposed upon private corporations by the laws of the State of Idaho, INOM SEDERAN & STATE

 except such as are inconsistent with the provisions of Title 20 Chapter 10, Ok. 181 CT. 1837 M: 159473

 of Idaho Code Annotated, as now existing or hereafter amended, governing nonprofit cooperative associations.

ARTICLE III

That the registered office of this corporation and the principal place for the transaction of its business is hereby designated as Pocatello, Bannock County, State of Idaho. ARTICLE IV

The number of directors of this corporation shall be not less than five, as may be fixed by the By-Laws; qualification of directors, their remuneration, terms of office, manner of election, time, place and manner of calling meetings, and their powers and duties and other matters not inconsistent with the law in the premises, may be prescribed by the By-Laws. ARTICLE VII

The corporation does have voting members. This corporation is not organized for pecuniary profit and shall not issue capital stock; the corporation shall issue a membership certificate to each of its members, which certificate cannot be assigned so that the transferee can by such transfer become a member of the corporation, nor otherwise, except by resolution by the Board of Directors and under such regulations as the By_Laws may prescribe. No member of the corporation can acquire a greater interest therein than any other member and the rights and interests of all members shall be equal.

ARTICLE VIII

Upon dissolution the assets shall be distributed to all active members at time of dissolution.

ARTICLE IX

That the duration of the corporation's existence shall be unlimited and perpetual.
