


CERTIFICATE OF INCORPORATION OF

ARTICLES OF INCORPORATION

OF

CTM DISTRIBUTING, INC.

KNOW ALL MEN BY THESE PRESENTS: That We, the undersigned, being a natural persons of full age and citizens of the United States, in order to form a corporation for the purposes hereinafter stated, pursuant to the Business Corporation Act of Idaho, do hereby certify as follows:

ARTICLE I

The name of the corporation is CTM DISTRIBUTING, INC.

ARTICLE II

The period of its duration is perpetual.

ARTICLE III

The corporation is organized for the purpose of conducting and transacting any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE IV

The aggregate number of shares which the corporation shall have authority to issue is 100,000 shares and shall have no par value.

ARTICLE V

Provisions for the regulation of the internal affairs of the corporation are as shall be set forth in the Bylaws of the corporation as from time to time be adopted or amended.

ARTICLE VI

The address of the initial registered office of the corporation is 3009 Greenhurst Road, Nampa, Idaho 83651 , and the name of its initial registered agent at such address is Clint Murray.

ARTICLE VII

The number of directors constituting the Board of Directors of the corporation is one or such greater number not to exceed five as shall be fixed by the Bylaws.
