Articles of Incorporation for Northwest Wolfers, Inc.

The name of the organization for incorporation shall be known as Northwest Wolfers, Inc. It is a non-profit organization. The following are its goals and purposes.

- I. To enforce and protect the following rights of the Wolf Hybrid:
 - A. Understanding of the breed
 - B. Responsible breeding
 - C. Proper nutrition
 - D. Proper environment
 - E. Encouragement of training
 - F. Proper medical care
- II. To educate our communities about Wolf Hybrids and Wolves.
- III. To promote and participate in standardization of the breed and reformation of the image of Wolf Hybrids and Wolves.
- IV. To actively support Wolf Recovery.
- V. To work with our lawmakers concerning any legislation about Wolf Hybrids or Wolves.

The duration of this organization shall be perpetual. Northwest Wolfers, Inc. will have members. Each person will submit an annual assessment for membership set by the Board of Directors. Each member will receive one vote on each matter submitted to Northwest Wolfers, Inc. meetings for members.

The management of Northwest Wolfers, Inc. affairs will be vested in its Board of Directors. The Board will consist of five members. The five seats on the Board of Directors will be up for election by the organizational membership annually. Any member of the Board can serve consecutive terms. Each future member of the Board of Directors shall be a current member
