KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, acting as incorporators of a corporation under the Idaho Professional Service Corporation Act, adopt the following Articles of Incorporation for such corporation:

**FIRST**

The name of the corporation is ELLIS CHIROPRACTIC, PC

**SECOND**

The period of its duration is perpetual.

**THIRD**

The purpose or purposes for which the corporation is organized are:

1. To engage in the practice of chiropractic medicine as a professional corporation and to own and operate a chiropractic medical clinic for the purposes of providing chiropractic care and treatment and all other things incidental thereto necessary to conduct business; and

2. The transaction of all other lawful business for which corporations may be incorporated under the Idaho Professional Service Corporation Act, Section 30-1-3.

**FOURTH**

The aggregate number of shares which the corporation shall have authority to issue is ten thousand shares with no par value common stock.

**FIFTH**

Shareholders shall have full pre-emptive rights.

Provisions for the regulation of the internal affairs of the corporation are such as may be provided by the By-Laws of the corporation, including provision for restriction on transfer of shares, as provided in Idaho Professional Corporation Act, Section 30-1-23A as amended.

**SEVENTH**

The address of the initial registered office of the corporation is 745 West Bridge, Blackfoot, Idaho, 83221, and the name of its initial registered agent at such address is Valden Ellis.

**EIGHTH**

The number of directors constituting the initial Board of Directors of the corporation is one, and the names and addresses of persons who are to serve as Directors until the first annual meeting of shareholders, or until the first annual meeting of shareholders, or until their successors are elected and shall qualify are:




