ARTICLES OF INCORPORATION

OF

KNOW ALL BY THESE PRESENTS:

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

I.

The name of the corporation is OSBORNE AND CORRAO, INC.

II.

The period of its duration is perpetual.

TII.

The purpose of the corporation is to engage in any and all lawful business for which corporations may be organized under the Idaho Business Corporation Act and also the following purposes:

Forest resource management and consulting to include but not be limited to the management and consulting of the business of forest product producing, merchandising, cultivating, growing, harvesting, buying, selling and all other businesses incident thereto or connected therewith.

IV.
