

ARTICLES OF INCORPORATION,
of the

KNOW ALL MEN BY THESE PRESENTS, That we the undersigned have this
9 day of January A. D. 1904 voluntarily associated
ourselves together for the purpose of forming a corporation under
the laws of the State of Idaho:

AND WE CERTIFY,

First. That the name of this corporation is the _____

American Ridge Chapel ~~Church~~ of Kendrick, Idaho.

Second. That the purpose for which this corporation is formed
is to carry on, support, and maintain the worship of Almighty God in
accordance with the customs and usages of the _____

American Ridge Chapel ~~Church~~.

Third. That the place where the principal business of this
corporation is to be transacted is Kendrick, Idaho.

Fourth. That this corporation shall exist for a term of fifty
years from and after the date of its incorporation.

Fifth. That the number of trustees shall be Three to
be elected at an annual meeting held on the 12 day of
November A.D. 1903, and who shall hold
their office for a term of one year or until their successors are
elected and have qualified.

Sixth. That on the 12 day of November
A. D. 1903, at the town of Kendrick, in the County of Latah, in the
State of Idaho there was held an election by the members of the
above named association for the purpose of electing trustees for
said corporation, and that a majority of said members were present
and voted at said election.

Seventh. That G. E. Kelly, J. H. Brilhart and
J. Davidson were the officers that were
chosen by said association to conduct the aforesaid election, and
that they did conduct said election.

Eighth. That the name and residence of those who were elected
at said election as its trustees for the first year are:

G. E. Kelly OF Kendrick, Idaho.

G. H. Brillhart of Kendrick, Idaho.

J. Davidson of Kendrick, Idaho.
