JONES, SR., and NANCY E. JONES, desire to form a corporation pursuant to the provision of 30-1-1, et seq.,

Idaho Code, and hereby adopt the following Articles of Incorporation:

ARTICLE ONE

The name of the Corporation is:

ARTICLE TWO

The purpose of the corporation is to engage in any or all lawful business for which corporations may be organized under the provisions of 30-1-1, et seq., Idaho Code.

ARTICLE THREE

The period of duration of the corporation is perpetual.
