### **DISSOLUTION OF ASSETS CLAUSE**

Upon the DISSOLUTION OF THIS CORPORATION, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed for one or more exempt purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code, as determined by the then- current Board of Directors to be another Christian FAITH-BASED, non-profit organization with a like cause and mission that falls within the scope of Section 501 (c) (3) of the Internal Revenue Code.

Love Inc. is the first choice of the current Board of Directors to receive assets upon dissolution, provided it still meets the qualifications of Section 501 (c) (3) of the Internal Revenue Code.
