ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, full age Citizens of the United States, have this day voluntarily associated ourselves together for the purpose of forming a Corporation under the laws of the State of Idaho, and we hereby certify:

FIRST: That the name of this corporation is:

"ALLIED BUILDERS SUPPLY CO."

SECOND: That the purposes for which this corporation is formed are to manufacture, buy, sell and generally deal in brick, stone, lumber, cement, hardware, fixtures and any and all materials of whatsoever kind or nature capable of use in the construction of any kind of building or structure and to generally carry on a business of wholesale and retail dealers in building materials; to purchase, hold and deal in real and personal property; to erect, own, manage, operate, lease and sell buildings and structures; to buy, lease or otherwise acquire, maintain and operate sawmills and lumber yards; to invest in, advance and loan money on real, personal and mixed securities; to purchase, receive, hold and own bonds, mortgages, debentures, notes, shares of capital stock of corporations and other securities, obligations, contracts and evidences of indebtedness; to do such other ordinary and necessary things incidental and appurtenant to any and all of the foregoing purposes; and to pursue any and all other lawful business purposes without restriction or limitation to the foregoing enumerated purposes.

THIRD: That the time of existance of this corporation is Fifty (50) years from and after the date of its incorporation.

FOURTH: The location and Post office address of the registered office of this corporation shall be Challis, Idaho.

FIFTH: That the aggregate value of the capital stock of this corporation is TEN THOUSAND and NO/100 (\$10,000.00) DOLLARS, divided into One Hundred (100) shares, of a par value of One Hundred and No/100 (\$100.00) Dollars per share.

SIXTH: That there is only one class of stock in this corporation, which is common stock 100 shares in number, the holder of each share being entitled to one vote for each share. The stock of this corporation is non-assessable and cannot be assessed for any purpose whatsoever.


