WE, THE UNDERSIGNED, all residents of the State of Idaho, and citizens of the United States of America, all of full age of majority, have for the purposes of forming a non-profit cooperative association, under and pursuant to Chapter 3, Title 30, Idaho Code, entitled "Non-Profit Corporations", adopted the following Articles of Incorporation:

1. NAME: The name of the Corporation is AYUDAS, INC.
2. NON-PROFIT: AYUDAS, INC. is a non-profit corporation.
3. DURATION. The period of duration of the Corporation shall be perpetual.
4. PURPOSES: The Corporation is organized and operated exclusively for the promotion of social welfare, and not for pecuniary profit. The purpose of the Corporation is to facilitate the use of public and/or private agencies by persons in need of the services provided by said agencies with special emphasis on the Spanish-speaking population.
5. MEMBERSHIP: Membership of the Corporation shall be determined by the By-laws. There shall be no capital stock. Each member shall have one equal vote.
6. ELECTION OF DIRECTORS. Directors of the Corporation shall be elected in the manner provided by the By-laws.
7. ADDRESS: The address of the initial registered office of the Corporation is as follows:
