ARTICLES OF AMENDMENT OF JOBS PLUS, INC. An Idaho Nonprofit Corporation

KNOW ALL MEN BY THESE PRESENTS that the Corporation held a meeting of its members on the 15th day of September, 1993, at which a quorum of the membership was present. At the meeting, a majority of the members present, either by proxy or in person, cast votes in favor of the following amendment to the Articles of Incorporation.

- 1. The name of the corporation is JOBS PLUS, INC.
- 2. Forty-five members were entitled to vote on the following amendment, of which forty-five members voted FOR the amendment to the Articles of Incorporation, and no members voted AGAINST said amendment.

3. AMENDMENT

ARTICLE VI - ORGANIZATION

The Corporation is to be organized upon a non-stock certificate of membership basis. Such memberships shall be non-redeemable, non-certainsferrable, and non-dividend bearing. There shall be two classes of membership. The voting class are all those members who have contributed \$500 or more during the fiscal year. All those contributing less than \$500 per fiscal year shall have no vote. Any member not contributing during the fiscal year shall have membership in the Corporation automatically terminated.
