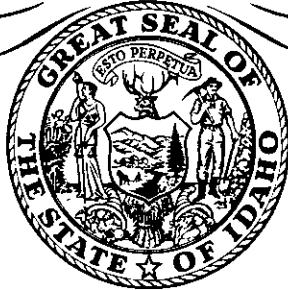

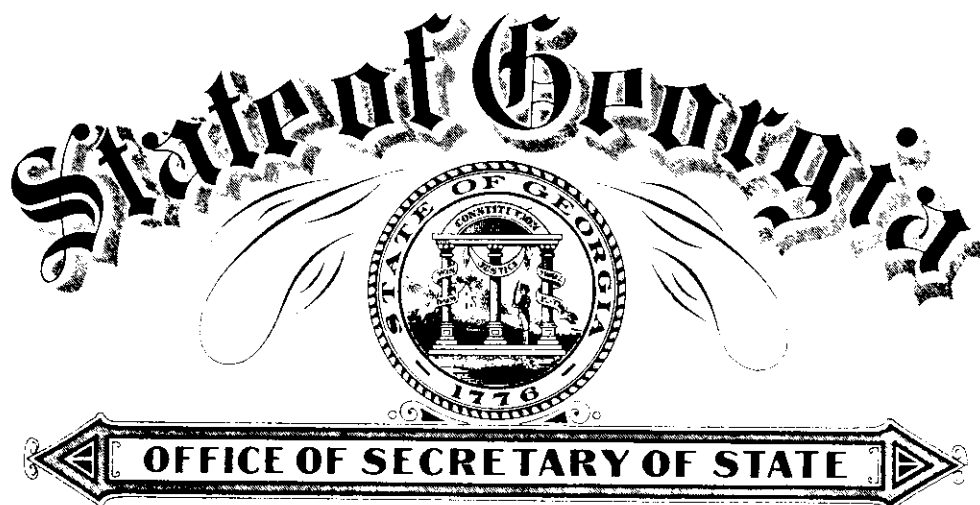

common stock shall have one vote for each share of voting common stock held at any and all meetings of the stockholders and said Class B voting common stock shall be the sole and only stock entitled to vote. Said Class B voting and Class A non-voting common stock shall be issued in exchange for the presently outstanding 1,000 shares of common stock without par or stated value at the rate of 20 shares of Class B voting common stock and 180 shares of Class A non-voting common stock for each one share of presently outstanding common stock.
