**ARTICLES OF INCORPORATION

**THE UNDERSIGNED**, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

**FIRST:** The name of the corporation is **EXCELL LOGGING & FORESTRY INC.**

**SECOND:** The period of its duration is perpetual.

**THIRD:** The purpose or purposes for which the corporation is organized are: the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

**FOURTH:** The aggregate number of shares which the corporation shall have authority to issue is one thousand. The par value shall be one dollar per share.

**FIFTH:** Provisions denying preemptive rights are: none.

**SIXTH:** Provisions for the regulation of the internal affairs of the corporation shall be provided for in the by-laws of the corporation.


