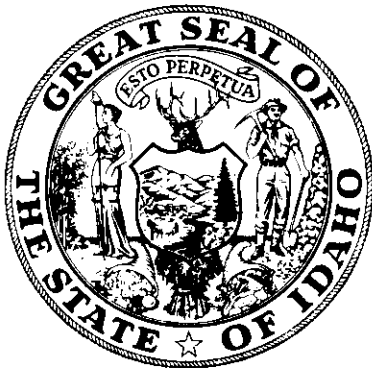

ARTICLES OF AMENDMENT  
OF  
CHALLIS FRIENDS OF THE LIBRARY, INC.

At the October 3, 1983 meeting of the CHALLIS FRIENDS OF THE LIBRARY, INC. a motion was passed by unanimous vote to amend the ARTICLES OF INCORPORATION to comply with SECTION 501 (c) (3) of the INTERNAL REVENUE CODE. The meeting was held in the city of Challis, County of Custer, State of Idaho.

The following articles were amended to read:

I.

This Corporation is a non-profit corporation formed pursuant to the "Idaho Nonprofit Corporation Act". No part of the net earnings shall inure to the benefit of any private shareholder.

IV.

The period of existence and the duration of the life of this corporation shall be perpetual. Upon the winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligations of the organization, the remaining assets shall become the property of the Challis Public Library.

X.

The purpose for which the corporation is organized is to assist the Challis Public Library Board and provide support and aid to surrounding area Library functions and to perform any and all other acts lawful under the "Idaho Nonprofit Corporation Act" and within the meaning of Section 501 (c) (3) of the Internal Revenue Code without limit. Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal Income Tax under Section 501 (c) (3) of the Internal Revenue Code.
