ARTICLES OF INCORPORATION OF GENESEE FLYING SERVICE, INC.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, all full-age citizens of the United States, have this day voluntarily associated ourselves together for the purpose of forming a business corporation, in compliance with Chapter One, Title 30, Idaho Code, as amended, and for such purpose we hereby make, execute and adopt the following Articles of Incorporation.

ARTICLE ONE

Name

The name of the corporation shall be:

"GENESEE FLYING SERVICE, INC."

ARTICLE TWO

Purposes

The purposes for which said corporation is formed and organized are:

Anywhere in the United States and its territories and particularly in the State of Idaho, to engage in and carry on any part or all of the following businesses, to-wit:

- (1) To generally engage in, do and perform any enterprise, act or vocation that a natural person might or could do or perform.
 - (2) To engage in the business of spraying or dusting of

agricultural crops, timber lands, grazing lands, bodies of water or streams by airplanes and to contract and subcontract for or with individuals or any political subdivision of any State or Government Agency necessary for carrying out the business of dusting and spraying such crops, timberlands, grazing lands, bodies of water or streams, for the control of weeds, eradication of insects, fertilization of soils, preventing, control or elimination of fires, as an aid in propagation of fish or destruction thereof, and for the doing of any and all other services whether now known or hereinafter enumerated or hereafter to become known wherein application of any substance by use of airplane or rotary-blade machine, and related equipment, may be desired for a lawful purpose.

- (3) To make, enter, perform and discharge contracts necessary for carrying out the purposes of the corporation.
- (4) To transact the business of investing on behalf of itself or others, and parts of its capital and such additional funds as it may obtain, or any interest therein, either as tenant in common or otherwise, or selling or otherwise disposing of the same, or any part thereof, or interest therein.
- (5) To contract and hire labor necessary or convenient to the conducting and operation if said business.
- (6) To appoint such officers, employees and agents as the business of the corporation may require, and to allow them compensation.

- (7) To use and apply to surplus earnings or cumulative profits to the purchase or acquisition of its own capital stock from time to time, and to such extent and in such manner and upon such terms as its board of directors shall determine.
- (8) To invest surplus funds from time to time at the discretion of the board of directors of the corporation.
- (9) To make by-laws not inconsistent with any existing law for the management of its business and property, the regulation and conduct of its affairs, and the certification and transfer of its stock.
- (10) To do all lawful acts as are necessary and expedient to accomplish the stated purposes of this corporation.
- (11) The purposes specified herein shall be construed both as purposes and powers and shall be in no wise limited or restricted by reference to, or inference from, the terms of any other clause in this or any other article, but the purposes and powers specified in each of the clauses herein shall be regarded as independent purposes and powers, and the enumeration of specific purposes and powers shall not be construed to limit or restrict in any manner the meaning of general terms or of the general powers of the corporation; nor shall be expression of one thing be deemed to exclude another, although it be of like nature not expressed.

ARTICLE THREE

Existence

The corporation shall have a perpetual existence.

ARTICLE FOUR

Location

The principal office and place of business of this corporation shall be at Genesee, in the County of Latah, State of Idaho, but the corporation office address may be changed by the Board of Directors, and branch offices or places of business may be located or established by the corporation at such other places within or without the State of Idaho as the Board of Directors may decide upon and meetings of the Board of Directors may be held at any such branch offices or places of business of the corporation and the business of the corporation transacted there.

ARTICLE FIVE

Capital Stock

The capital stock of the corporation shall consist of Twenty-Five Hundred Shares of capital stock, same being common voting stock, at Ten (\$10.00) Dollars per share par value for a total capitalization of \$25,000.00. Each share of common stock shall have one full vote at the stockholders meetings of the corporation.

Directors

The number of directors of this corporation shall be not less than three nor more than five; and the number of qualifications, terms of office, manner of election, time and place of meetings, and powers of directors, and their duties, shall be such as are prescribed by the by-laws of this corporation.

ARTICLE EIGHT

By-Laws

The Board of Directors of this corporation shall have the power to adopt all by-laws, and the same may be modified or amended by the Board of Directors, subject, however, to the power of the shareholders to change or repeal such by-laws.
