### CERTIFICATE OF INCORPORATION

**IDaho MOTOR TRANSPORT ASSOCIATION, INC.**

was filed in the office of the Secretary of State on the **twenty-fifth** day  
of **May** **A. D. One Thousand Nine Hundred thirty-nine** and  
is duly recorded in Book **A-32** of Record of Domestic Corporations, of the State of Idaho,  
and that the said articles contain the statement of facts required by Section 29-103 and Sections  
29-1001 to 29-1005, inclusive, Idaho Code, Annotated.

**I FURTHER CERTIFY,** That the persons executing the articles and their associates and  
successors are hereby constituted a corporation, by the name hereinbefore stated, for **fifty**  
**years** from the date hereof, with its registered office in this State located at  
**Boise** in the County of **Ada**,  
and as such are subject to the rights, privileges and limitations granted to Non-Profit Cooperative  
Associations, as provided in Chapter 10, Title 29, Idaho Code, Annotated.

ARTICLES OF ASSOCIATION

of the

IDAHO MOTOR TRANSPORT ASSOCIATION, INC.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, being seven natural persons of full age and citizens and bona fide residents of the State of Idaho, have this day voluntarily associated ourselves together for the purpose of forming a non-profit cooperative association under the laws of the state of Idaho, and we do hereby certify:

ARTICLE I.

That the name of said corporation shall be:

IDAHO MOTOR TRANSPORT ASSOCIATION, INC.

ARTICLE II.

The purposes for which this association is formed are:

(a) To promote a cooperative spirit within the motor transportation industry and to advance the best interests of the industry in the state of Idaho;

(b) To cooperate with all law enforcement officers in the enforcement of all motor vehicle and traffic laws, ordinances and regulations;

(c) To promote the proper use of the highways and to encourage the proper maintenance and construction of the state highways;

(d) To urge just and rational highway legislation and to support the enactment of any and all legislation which

is conducive to the best interests of businesses and industries in which the motor transportation industry has a direct interest;

(e) To affiliate or associate with other similar associations or organizations of a state or national kind and such organizations within the state of Idaho;

(f) To purchase, hold, convey, mortgage and encumber real and personal property and to borrow money with or without securing the same with the property of the association as the purposes of the association may require;

(g) To organize, promote and advertise safety and educational campaigns in the use of the highways of this state;

(h) To protect the interests of the members of the association when to so do does not interfere with any of the purposes for which the association is formed;

(i) To carry on and promote any undertakings which are calculated directly or indirectly to promote the interests of this association and generally to have, enjoy and exercise all the rights, powers and privileges which have now or may hereafter be conferred upon non-profitable cooperative associations organized under the laws of the state of Idaho, and to do all things necessary, suitable, convenient or proper for the accomplishment of the purposes and this to the same extent and as fully as natural persons might or could do.

### ARTICLE III.

The term for which this corporation shall exist shall be for fifty years.

#### ARTICLE IV.

The location and post office address of its registered office in this state and its principal place of business shall be at Boise City, Ada County, Idaho.

#### ARTICLE V.

This association shall not issue any capital stock but shall issue membership certificates to each member thereof, which certificates cannot be assigned so that the transferee can by such transfer become a member of the association, except by resolution of the board of directors and under such regulations as the by-laws may prescribe.

#### ARTICLE VI.

The number of directors of this association shall be seven, and the names and residences of the directors who are to act in the capacity of directors until the election of their successors are:

and such directors shall hereafter be elected or selected in such manner and shall serve for such period of time as

the by-laws may prescribe and the number of such directors may be changed by an amendment to the by-laws. The by-laws shall provide for annual dues and the levying of special assessments by the board of directors and the method of collection thereof.
