

ARTICLES OF AMENDMENT TO CORPORATE CHARTER

HOSPICE OF NORTH IDAHO, INC. Services

SI MAY 13 FT 2 59

We, the undersigned, being the directors of Hospice of North Idaho, Inc., an Idaho non-profit corporation, have this 25 day of April, 1991, at a duly called board meeting of the corporation, pursuant to Idaho Code § 30-325 and 326(b), have adopted by a majority vote of the directors then in office, the following amendment to the Articles of Incorporation of the corporation.

Original Provision (as amended May, 1982) 5: MEMBERSHIP. Corporation will be a non-membership corporation with the first elected Board of Directors being appointed by the Coeur d'Alene Homes, Inc., an Idaho non-profit corporation, pursuant to Idaho Code Section 30-314(b).

Amended Provision (as stated in original Articles of 1981) 5: MEMBERSHIP. The corporation will be a membership corporation with one class of membership.
