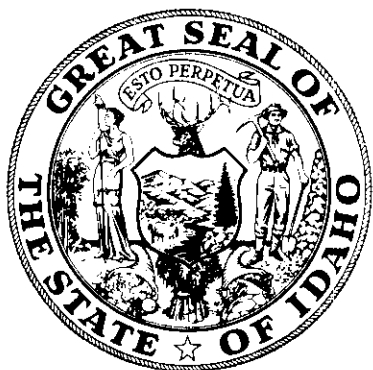

ARTICLES OF INCORPORATION
OF
SNOW CLOUD CORPORATION

The undersigned, acting as incorporator under the provisions of the Idaho Business Corporation Act, adopts the following Articles of Incorporation:

1. NAME. The name of the corporation is: SNOW CLOUD CORPORATION

2. DURATION. The period of its duration is perpetual.

3. PURPOSES. The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act, which shall include but not be limited to the sale and purchase and dealing in real and personal property.

4. STOCK. The corporation shall have the authority to issue 2,500 shares of capital stock, all of one (1) class, all no par value.


