KNOW ALL MEN BY THESE PRESENTS: That Jerry C. Simonson and L.M. Hewett, the undersigned, being natural persons of legal age and citizens of the United States of America, in order to form a corporation for the purposes hereinafter stated, pursuant to the laws of the State of Idaho, do hereby certify as follows:

I.

Name

The name of the corporation shall be 12th Avenue Farm Market, Inc.

II.

Registered Office

The location and post office address of the corporation shall be 3106 12th Avenue Road, Nampa, Idaho 83686.

III.

Registered Agent

The name and address of the registered agent of the corporation is: Jerry C. Simonson, 3106 12th Avenue Road, Nampa, Idaho 83686.

IV.

Duration

The period of existence and duration of the corporation shall be perpetual.

V.

Corporation Purposes

A. To merchandise, sell, offer for sale, and distribute at wholesale and retail, foods and foodstuffs of all kinds and descriptions, whether in bulk, package, bottle, or can, including beverages of all kinds and for all purposes, and to generally deal in grocery and grocery products.

B. To conduct and transact any and all other lawful business for which corporations may be incorporated under the Idaho Business Corporation Act and to have, exercise and enjoy all of the powers now or hereafter granted to corporations organized under the laws of the State of Idaho, and particularly all of the powers and priveleges granted to corporations by Chapter 1 of Title 30 of the Idaho Code, and any present and future amendments thereto, and to do any act or thing necessary or convenient for the transaction of the aforementioned business purposes and the carrying into effect of any and all of the aforesaid objects and purposes.

VI.

Authorized Capital Stock

The corporation shall have 1000 shares of common stock, of no par value. Each share shall have the same rights, priveleges and voting power and shall be nonassessable.

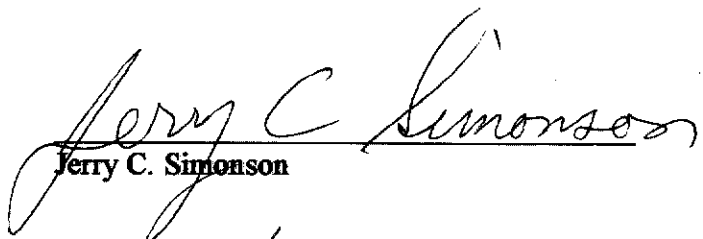
The initial directors shall serve until the first election of directors.

IX

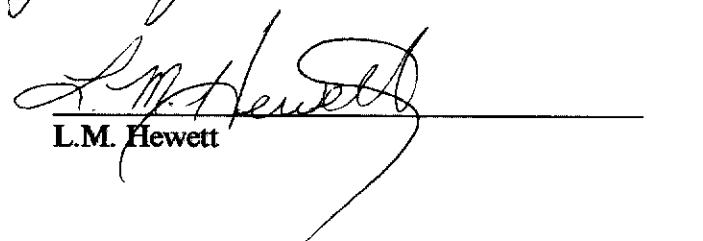
By-Laws
