Dear Mr. Ball:

Your e-mail dated May 25, 2012 requesting approval of the assumed business name "Jumpin Beans Mobile Food Bank" for use in the state of Idaho has been received by the Idaho Department of Finance (Department) and has been reviewed by Department staff. We understand from your e-mail that Gem Community Citizens Project Group, Inc. (GCCPG), a 501 (c)(3) organization, will operate Jumpin' Beans Mobile Food Bank in conjunction with the Hayden Senior Center. The mobile food bank delivers food to elderly, frail, and disabled individuals who are unable to drive or otherwise get to a regular food bank.

Section 26-1202 of the Idaho Bank Act prohibits any person, other than a national bank, not authorized to operate as a bank under the Act, to advertise or use as part of its company name the word "bank" or "banker" or any other word of similar import. The Idaho Bank Act does not authorize the Director of the Idaho Department of Finance to waive the requirements of the law. Rather, the Department is offering "no objection" to GCCPG's use in Idaho of the assumed business name "Jumpin' Beans Mobile Food Bank." Based upon the information provided in your letter, we do not believe the name proposed by that company for use in Idaho is misleading to the public. While the Department does not intend to pursue an action under this statute, it is possible that another agency may do so. However, we believe the likelihood is slight.
