The undersigned, acting as incorporator of a Nonprofit Corporation, under the Idaho Nonprofit Corporation Act, adopts the following Articles of Incorporation for such Corporation.

**FIRST**

The name of the Corporation is THE DUNES AT SANDCREEK HOMEOWNER'S ASSOCIATION, INC.

**SECOND**

The period of duration is perpetual.

**THIRD**

The purpose or purposes for which the Corporation is organized are: The transaction of any and all lawful business for which Nonprofit Corporations may be incorporated under the Idaho Nonprofit Corporation Act.

The Corporation is specifically created to transact any and all lawful business purposes related to management and protection of conditions and covenants in a homeowners association.

**FOURTH**

The Corporation shall have voting members defined as the titled owner(s) of a lot in the Dunes at Sandcreek, Division No. 1 and Division No. 2 in the City of Idaho Falls, Idaho as shown on the plats recorded in the records of Bonneville County, Idaho, and as may be further defined, identified and described in the Corporation's Bylaws.

**FIFTH**

Upon dissolution, all assets of the Corporation shall be distributed in accordance with Idaho Code § 30-3-109 and other applicable provisions of law.

**SIXTH**

Each member shall be liable for the payment of assessments as levied by the Association's Board of Directors in accordance with the Declaration and Bylaws. Such assessments shall be secured by a lien upon the real property to which a member's membership


